Overview of the Position and Volunteer Responsibilities

The Ottawa-Carleton Ultimate Association (OCUA) Board of Directors provides strategic leadership, governance, establishes policy, oversees the operations and financial performance of the Ottawa-Carleton Ultimate Association and assesses the Board's own effectiveness. Our Board Members will serve on several committees, including:

- Governance and Risk

- COVID

In addition to regular duties, Directors are encouraged to bring forward and lead interest projects that support the Mission, Vision and Values of the organization; such as:

- Capital Investments
- Long Term Strategic Plan
- Technology
- Data and Metrics

- Policy Development
- Rules of the Game, Spirit of the Game
- Youth and Juniors Growth

New members will be supported and mentored by the existing Board of Directors to help ease the transition into this leadership role. Participation on the Board is voluntary and there is no remuneration for service.

Time Commitment

The total expected time commitment is approximately 10-15 hours per month. The time commitment may vary depending on members' involvement in committee work, outreach, and the time preparing for meetings.

The Board generally has 10 regular meetings each year which are currently held virtually, on the third Tuesday of the month.

Nomination Process

The Nominations Committee encourages all candidates to submit to a formal evaluation process. An endorsement by the Nominations Committee is not a guarantee of election - an open vote of Members will determine the Board.

A. Nominations by Committee

Applications to the Nominations Committee can be submitted online by **Sunday March 12, 2023** by completing the:

The Nominations Committee will advise of its nominations by Monday March 13th, 2023. If you are not successful in obtaining a nomination from the Nominations Committee, you may still run for election by obtaining a nomination from the membership.

B. Nominations from the Membership

Nominations from the Membership can be submitted online by **Tuesday March 28**, **2023** by obtaining signatures* of 25 Members of the Association supporting your candidacy and completing the:

* At this time, full names and e-mail addresses will be accepted in lieu of physical signatures. The Nominations Committee may contact your sponsors to validate the nomination.

Eligibility Criteria

To be eligible to serve on the Board of Directors a candidate must:

- a) Be 18 years of age or older
- b) Be a member of the Association in good standing
- c) Reside in or a reasonable distance from the National Capital Region
- d) Not be an undischarged bankrupt

Candidates should also be able to demonstrate a few of the following types of experience and knowledge:

- Organizational resilience
- Financial literacy
- Integrity and mutual support
- Leadership and management
- Governance and diplomacy
- Team-building and facilitation

- Strategic planning and innovation
- Marketing and communications
- Health and Safety
- Human resources
- Facilities or sports management
- Legal
