Annual General Meeting

Thanks to all members who attended our virtual Annual General Meeting (Saturday April 24, 2021) as we appointed Welch LLP as OCUA's Public Accountant for the 2020-2021 financial year, had a lively discussion around the proposed by-law amendments, and elected four new Directors. Congratulations to the newly elected Directors Chris McMahon, Kelly Fulton, Laura Storey and Luke Krolak.Thank you to everyone who put their name forward.

The majority of the by-law amendments passed, including a mechanism to allow for advance electronic voting for future elections. The unsuccessful amendment was the change to quorum which the Board will be addressing at the 2022 AGM.
