# Sooners Mega Dome Covid-19 Policies

## Vaccination Policy:

All patrons entering the Sooners Mega Dome must provide their proof of identification and proof of being fully vaccinated. The proof of vaccination must show that the patron received their final dose least 14 days before entering the facility.

#### An individual is considered fully vaccinated if they have received:

- The full series of a COVID-19 vaccine authorized by Health Canada, or any combination of such vaccines, or
- One or two doses of a COVID-19 vaccine not authorized by Health Canada, followed by one dose of a COVID-19 mRNA vaccine authorized by Health Canada, or
- Three doses of a COVID-19 vaccine not authorized by Health Canada;

#### Exemptions:

- Children under 12 years of age.
- Proof of identification and proof of being fully vaccinated is not required for workers or volunteers, including coaches and officials.
- Patrons under 18 years of age who are entering the indoor premises of a facility used for sports and recreational fitness activities solely for the purpose of actively participating in an organized sport, in accordance with the guidance below:
  - The exemption relating to youth less than 18 years of age actively participating in indoor organized sport applies to training, practices, games and competitions.
  - The exemption does not apply to youth who are spectators at sporting events.
  - Proof of being fully vaccinated against COVID-19 and proof of identification (or proof of being entitled to another exemption) is required for patrons 18 years and older, including parents or guardians of youth actively participating in an organized sport.
- Patrons who provide proof of identification and proof of a medical exemption

### Proof of a medical exemption:

- The date of entry is prior to the expiration of the medical exemption.
- The name of the person in the written documentation matches the identification provided.
- The document was completed and supplied by a physician (designated as "MD") or by a registered nurse in the extended class (designated as "Registered Nurse (Extended Class)", "RN(EC)", "Nurse Practitioner" or "NP") stating that the individual is exempt for a medical reason from being fully vaccinated against COVID-19 and the effective time-period for the medical reason.
- The document must include:
  - Name and contact information of the physician or registered nurse in the extended class;
  - Logo or letterhead identifying the physician or registered nurse in the extended class;
  - Statement that there is a medical reason for the individual's exemption from being fully vaccinated against COVID-19; and

• Any effective time-period for the medical exemption.

## **Rental Policy:**

#### Patrons are defined as players, coaches, volunteers, spectators, and parents/guardians.

All Patrons must comply with the current guidelines, regulations and recommendations related to COVID-19 by Ottawa Public Health, the Municipal and Provincial government, the sport governing body and their Association.

Contract holders must:

- Ensure all patrons related to their rentals have completed and passed a COVID-19 selfassessment prior to entering the facility. All assessments must be completed the same day patrons are attending.
- Collect contact information to support contact tracing.
- Have a safety plan in place for all rentals.
- Actively screen all patrons associated with the rental before they enter the facility.
- Take attendance for each date on the contract and for each patron accessing the space during the rental period. Records must be kept for one month (31 days) for the purpose of tracing in the event of a COVID-19 outbreak.
- limit the time of patrons inside the facility to 15 minutes before and after their associated usage to alleviate capacity issues.

There are no restrictions on team sports. Physical contact, size of teams, cohorts or any other game play scenarios can resume.

The total number of patrons permitted to be in the facility associated with the rental of each field at any one time is limited to 100. Maximum capacity will be posted outside of the facility. Contract holder is responsible to ensure the capacity limit is not exceeded.

Any patron that enters or uses the facility (or when waiting in line outside the facility) other than when participating in a team sport, must wear a mask and maintain a physical distance of at least 2 meters from any other person who is using the facility unless within the same household.

All patrons must comply with COVID-19 guidelines issued by the Sooners Mega Dome, Ottawa Public Health, and Public Health Ontario at all times. Failure to comply will result in immediate removal from the facility, non-refundable field cancellation and review of future contract bookings.

Conditions of use and contract amendments are subject to change with direction from the Provincial Guidelines and Regulations and Ottawa Public Health
